1) To better the works conditions of the construction workers.
2) Advice and help to promote the integration of colleagues in
Danish society.
3) Hold social activities for colleagues and their families.
4) Collaboration with all associations, authorities, individuals who also want
to promote the association's purpose.
4) Support BJMF's work for migrant workers' rights in Denmark.
5) Help BJMF recruit members.
6) Helping to maintain and expand the BJMF-immigrant's communications
platforms, as well as the clubs own communication platforms.
7) Help to create other and immigrant clubs in the Danish trade
union movement.

§2 Home of the club

- 1) The club resides in the trade union Bygge Jord og Miljøarbejdernes Fagforening (BJMF).
- 2) The club works within BJMF's organization limits, rules and purposes.

§3 Duties and rights

- 1) All who are speaking _____, and are a member of BJMF are a member of the club.
- 2) All members paya club contingent, through the union's dues to the club.
- 3) The Dues of the club are fixed by the general meeting.

§4 General Assembly.

- 1) The General Assembly is the highest authority of the club in all matters.
- 2) The General Assembly is convened with 14 days notice and is held annually in April.
- 3) The general assembly must be convened by at least a posting in the BJMF-Immigrant facebook page and website, and by email or sms to the members.
- 4) Proposals must reach the Board not later than 3 days prior to the event.
- 5) The agenda must contain at least:
- 1. Selection of the conductor and the writer of the minutes of the meeting.
- 2. Chairman's report.

- 3. The club's accounting.
- 4. Proposed proposals.
- 5. fixing club member dues.
- 6. Elections of the Chairman.
- 7. Elections of the rest of the board.
- 6) Voting is determined by ordinary voting by raising of hands. However, the vote must be done anonymously in writing, if at least three members wish this.

§5 Extraordinary General Meeting

1) A Extraordinary General Assembly may be convened, with a minimum of 14 days notice by the Board, or by the members if at least 1/5 of all the members submits a written request to that effect, stating the agenda.

§6 Member meetings

- 1) The Board is responsible for convening regular open meetings, for all members.
- 2) The purpose of the meetings is to involve as many members as possible in the club's daily work.
- 3) It is highly recommended that the member meetings take decisions by consensus. If this can not be achieved, it is the board that determines the club's policy.

§7 The Board of Directors

- 1) The board is the club's daily management.
- 2) A board of seven is elected by the General Assembly.
- 3) All paying members of the club can be elected to the board.
- 4) The board consists of: A chairman, a vice-chairman, a cashier and four ordinary members.
- 5) The cashier and the deputy chairman are elected from among the board members, by the board.
- 6) In addition, there may be elected supplementary deputies at the general Assembly. The board of directors elects which of the supplementary deputies, is to join the board, as needed.
- 7) If a member of the board does not attend three consecutive meetings, the member is excluded by the board.

§8 Accounting

- 1) The cashier must keep close account of the club funds. And the accounts must be submitted for inspection to the board, if one or more of the members of the board require this.
- 2) The accounts of the club are presented for approval at the general assembly.
- 3) All the funds of the association must be used for the purpose of the association, and at the general meeting the cashier must be presented with a statement showing that all funds have been used for this purpose.
- 4) The cashieren secures that the trade union receives the clubs dues and that the dues are transfers it to the club's accounts.

§9 Signing rights

The cashier, the vice-chairman and the chairman are entitled to sign the association if they are two in common. The chairman and vice-chairman, the cashier and the vice-chairman or the cashier and the vice-chairman, can sign the association.

§10 Dissolving the club

- 1) The club is dissolved if The General Assembly decides this, or if no General Assembly have been held in the club for two years.
- 2) If a General Assembly is not held for one year, the club is suspended where BJMF ensures the club's funds. The break ends at restart of the club at a General Assembly or by resolution of the club.
- 3) Upon resolution, any funds will be paid to BJMF, for use only in the unions efforts to organize migrant workers.
